4. The intending quotationers are required to furnish the following along with their quotations

- (i) Copy of up to date valid STCC/VAT/ITCC Clearance,
- (ii) Copy of PAN Card.
- (iii) Copy of document indicating residential address.
- (iv) Copies of documents on credentials and proofs in support of successful execution of the similar nature of works of similar magnitude. Undertaking to mobilize men, materials and machinery, equipments etc. to the site of work within 15(Fifteen) days from the date of issue work order/Letter of Intent by OCCL.
- (v) Copies of documents on ownership of machinery, equipments etc. available with the Job-Worker.
- (vi) Copy/Copies of agreement of Job-Worker with other agency/agencies to avail machinery, equipment, etc on hire or lease with proof of ownership of machinery.
- (vii) Copy of valid enlistment certificate as Job-Worker issued by OCCL.
- (viii) Copy of valid labour licence
- (ix) Copy of EPF Registration, if any.

5. The authority reserves the absolute right to accept or reject any or all quotations and to Split up works to award to one or more Job-Workers without assigning any reason there of.

The quotationer should produce documentary evidence regarding availability of the following machineries and equipments, in working condition required for execution of the work (either owned in his name or obtained on hire purchase scheme or by hiring from the reputed firms/contractors firms). If the machineries are to be produced for specific period of completion of the work on lease/rental basis then a copy of registered MOU must be attached.
