3. The quotations must be accompanied with Earnest Money Deposit of the amount specified for the work in the table above in any one of the forms specified in the quotation document and should be valid for 90(Ninety) days from the date of opening of quotations.

The quotations must be submitted to the Senior Manager(Civil), Orissa Construction Corporation Ltd., Manjore Group of Projects, Madhapur, Athamallick on or before 3.00 PM of Date 08.12.2011 and will be opened on the last day of receipt at 3.30 PM in the presence of the quotationers, who may like to be present. If there will be a public holiday on the last date of sale of quotation document and receipt & opening of the quotations as specified above, the quotation document will be sold and quotations will be received & opened on the next working day at the same time and venue.
5. Intending quotationers are required to furnish the following along with their quotations.
 - (i) Copy of up-to-date valid STCC/VAT clearance
 - (ii) Copy of PAN card
 - (iii) Copy of document indicating residential address
 - (iv) Copy of valid enlistment certificate as job-worker issued by "OCCL".
 - (v) Under taking to mobilize men,materials and machinery, equipments etc. to the site of work within 15 (Fifteen) days from the date of issue of work order by "OCCL".

7. The job-workers are to quote rates in the format enclosed with the quotation document.
