The quotations must be submitted to the Senior Manager(Civil), Orissa Construction Corporation Ltd., S.W.D.Project, Puri on or before **3.00 PM on 15.12.2011** and will be opened on the same day i.e. on **15.12.2011 at 4.00 PM** in presence of the quotationers, who may like to be present. If there will be a public holiday on the last date of sale of quotation document and receipt & opening of the quotations as specified above, the quotation document will be sold and quotations will be received & opened on the next working day at the same time and venue.

  - d. Copies of documents on credentials and proofs in support of successful execution of similar nature of works of similar magnitude
  - e. Undertaking to mobilize men, materials and machinery, equipments etc. to the site of work within 07 (Seven) days from the date of issue of work order / letter of intent by "OCCL".
  - f. Copies of documents on ownership of machinery, equipments etc. available with the job-worker
  - g. Copy/copies of agreement of job-worker with other agency/agencies to avail machinery, equipments etc. on hire or lease with proof of ownership of machinery
  - h. Copy of valid enlistment certificate as job-worker issued by "OCCL".
