3. The quotations must be accompanied with Earnest Money Deposit of the amount specified for the work in the table above in any one of the forms specified in Sl. No. – 2 above and should be valid for 90 days from the date of opening of quotations.

4. The quotations must be submitted to the General Manager (Civil),Projects, OCC Corporate Office, Gopabandhu Nagar, Unit-8, Bhubaneswar-12 on or before 3.00 P.M. dt. 31.12.11 and will be opened on the same day at 4.00 PM in the presence of the quotationers, who may like to be present. If there will be a public holiday of the last date of sale of quotation document and receipt & opening of the quotations as specified above, the quotation document will be sold and quotations will be received & opened on the next working day at the same time and venue.

5. Intending quotationers are required to furnish the following along with their quotations.

- (i) Required E.M.D.
- (ii) Copy up-to-date valid VAT clearance Certificate.
- (iii) Copy of PAN card.
- (iv) Copy of document indicating residential address.
- (v) Undertaking to mobilize men, materials & machinery, equipments etc. to the site of work within 7 (Seven) days from the date of issue of work order/letter of indent by “OCCL”.
- (vi) Copy of valid enlistment certificate as job-worker issued by “OCCL”.
- (vii) Copies of documents on credentials and proofs in support of successful execution of similar nature of works of similar magnitude.

6. The quotationer should produce documentary evidence regarding availability of the following machineries and equipments, in working condition required for execution of the work (either owned in his name or obtained on hire purchase scheme or by hiring from the reputed firms/contractors firms, if the machineries are to be produced for specific period of completion of the work on lease / rental basis then a copy of registered MOU must be attached. Failure to attach the documentary evidence in support of availability of required machineries may result in non-consideration of quotation.

7. The annual turn over of the job-worker should not be less than `414.00 lakhs in any one financial year during the last five years.
8. The job-worker should have executed in one year, the following minimum quantities of work.

9. The authority reserves the absolute right to accept or reject any or all quotations and to split up works to award to one or more job-workers without assigning any reason thereof.
10. The job-workers are to quote rates in sample format enclosed to the quotation document.
11. The job-workers shall have to execute work as per conditions of agreement.
12. The Quotationer shall submit the mode of execution/construction planning of the work.
13. If the job worker participate in more than one work in this tender and becomes lowest in more than one work, the authority reserves his right to award one or more work to him taking time factor into consideration.
14. If authority desire a part of the work will be given for execution in the 1<sup>st</sup> phase and the rest will be awarded subsequently.
15. Any dispute arising out of the above quotation call notice shall be subject jurisdiction of Hon'ble High Court of Orissa at Cuttack and their sub-ordinate courts at Bhubaneswar only.
