4. The intending quotationers are required to furnish the following along with their quotations

Undertaking to mobilize men, materials and machinery, equipments etc. to the site of work within 15(Fifteen) days from the date of issue work order/Letter of Intent by OCCL.
  - (v) Copies of documents on ownership of machinery, equipments etc. available with the Job-Worker.
  - (vi) Copy/Copies of agreement of Job-Worker with other agency/agencies to avail machinery, equipment, etc on hire or lease with proof of ownership of machinery.
  - (vii) Copy of valid enlistment certificate as Job-Worker issued by OCCL.
  - (viii) Copy of valid labour licence
