- (i) Angle grinder

Intending quotationers are required to furnish up-to-date valid STCC/VAT clearance, PAN along with their credentials and proof in support of manufacture and supply of similar machinery, detailed technical specifications of machinery etc. The rate for items should be quoted FOR Central Store & Machinery Project, Unit-8, Gopabandhu Nagar, Bhubaneswar - 751 012 in Odisha, which should include taxes, duties, transportation, transit insurance, handling charges, levies etc. as applicable but the applicable rates should be indicated separately in the offer.

4. Validity of quotations should be 90(Ninety) days from the date of opening of quotations.

5. The equipments are to be delivered within 7(Seven) days from the date of issue of purchase order.

6. 90(Ninety)% will be made against delivery of equipments in good conditions and testing and verification thereof and balance 10(Ten)% will be paid within 60(Sixty) days of receipt and satisfactory performance of equipments.

7. The test certificate and guarantee certificates of equipments will be furnished by the quotationers at their cost.
